

CAMPER REGISTRATION

Camping is a service provided for the convenience of our exhibitors. The following rules MUST be followed by all campers who use this service. Your cooperation is greatly appreciated.

All campers must be **pre-registered** and **pre-paid** by July 20, 2024. Campers may enter grounds on Friday 3pm- 8pm or Saturday 12pm-8pm. COST: Tents \$25, campers \$75 for 30ft and under anything over 31ft is \$100. All occupants must be listed on registration form and purchase an exhibitor or season pass. All campers and tents will be assigned a spot by a fair official, so designated. If a camper is on the grounds before Friday, it may be moved by fair officials. **There will be NO open fires, barbecue grills or gas grills allowed in the camper area. NO motor vehicles may be parked in the camping area. Each camper is required to provide their own back flow preventive device. Quiet time will be observed after midnight.**

1. Must Supply own extension cords.
2. New York State rule: NO AWNINGS, POP-UPS, OR EASY UPS
3. NO open fires or charcoal grills or GAS GRILLS
4. You must check in at the Fair office before finding your camping spot.
5. All campers must park in a specified area.
6. No one under the age of 21 will be allowed to stay in a camper without adult supervision.
7. ALL HOLDING TANKS MUST BE CLOSED.
8. In consideration for all campers, QUIET HOURS will be from 12:00 midnight until 7:00 a.m. No loud music, talking, etc. will be tolerated during these times. NO ALCOHOL WILL BE ALLOWED.
9. NO DOGS ALLOWED
10. NO FARM TRACTORS, VEHICLES OR COMMERCIAL (STORAGE) TRUCKS IN "CAMPER CITY".
11. No air conditioners
12. Camping fees do not include ticket prices.
13. Back flow preventors must be used, fair can supply one at \$40 deposit.
 - a. Any violations on your campsite from the Department of Health will be paid for by the camper's owner.
14. Pump out service is available for a fee.
